PRESIDENT'S REPORT

Operations Calendar

Vice President Govier reviewed the 2022 operations calendar for December. All items on track.

Town of Boulder Junction – Broadband Project (Fiduciary Account)

Board Member Van Grinsven reported that the Town has decided that it is not going to continue to actively fundraise. After disucssion with all Board members present, it was agreed that the Broadband Project Fund will be closed and the balance less the 2% fiduciary fee will be paid to the Town at its December 21 meeting.

Town of Boulder Junction - North Creek Loop Trail Project (Fiduciary Account)

Van Grinsven reported that as of the end of November there is total of \$316,542.87 in the North Creek Loop Bike Trail Project Fund. The Town of Boulder Junction has approved Phase I of the project and accepted the bid from Pitlik and Wick Contractors. Their work on the trails has begun. The North Creek Loop Trail fundraising committee has recommenced fundraising for the remaining amount of the project costs, approximately \$222,000. After discussion and input from all Board members, it was agreed that a check in the amount of \$217,299 will be issued to the Town of Boulder Junction which reflects the donations to meet the match requirement of the DNR Knowles-Nelson Grant and be presented at the Town meeting on December 21, 2022.

Town of Boulder Junction – Playground Project (Fiduciary Account)

Van Grinsven reported that \$109,212 was paid out to the Town of Boulder Junction for invoices presented for the Playground Project. This total reflects 50% of Equipment Costs ordered this fall. There is \$84,378 in the fund as of November 30th. The Playground Fundraising Committee is actively fundraising for all phases of the project.

Community Foundation of North Central Wisconsin

Secretary Rondello recapped the decision analysis process that our Board has taken over the past 12 months regarding the Affiliate Program option, which was proposed by Tim Parker, CEO of CFONCW in January of 2022.

Vice President Govier reported on the one-on-one meetings with community members to share the Affiliate Program option and ask for feedback. The community outreach included individuals who have had a longtime connection to the Foundation as either a founding board member, board consultant, a longtime supporter, or in an elected leadership role, past and present, for the Town of Boulder Junction.

In all, Van Grinsven, Govier and Rondello met 11 community members. All said yes to the milestone of becoming an Affiliate. Additionally, both the Foundation legal consultant and financial advisor said yes as well.

Van Grinsven reviewed the projected 2023 budget in the Affiliate Program scenario, highlighting the significant savings. Overall, the CFONCW would provide professional management services in key areas such as accounting, bookkeeping, administrative, mailing, and fundraising expenses, thereby saving the Foundation time, money, and volunteer resources.

The benefit of an Affiliation is three-fold: 1. fiscal responsibility to our donors 2. volunteer and independent contractor limited resources 3. Board members will have the time to do the things we've always wanted – building relationships. The overarching goals are to be good fiscal stewards of the funds entrusted to the Foundation and guarantee the future of the Foundation.

MOTION: Authorize the Foundation Executive Committee to execute an Affiliate Agreement effective January 01, 2023 and to establish the Boulder Junction Community Foundation Family of Funds as an affiliated fund of the Community Foundation of North Central Wisconsin.

YEAR END DISTRIBUTION OF FUNDS AND IRS UPDATE

- a. Spear reported on the meeting with Wipfli LLP regarding audit requirements. Senior leadership at Wipfli stated as per General Accounting principles, an audit is not necessary for fiscal year 2022 because the fiduciary funds are not income; they are a classified as a liability therefore the Foundation has not raised the threshold for an audit which is \$500,000. Additionally, an annual review is not required.
- b. Peterson Metz will do the 990 for us this year.
- c. Spear recommend that we hold off on moving a year end distribution of the Greatest Needs Fund to the Restricted Endowment Fund until we have gotten through the Affiliate Program transition process.
