<u>Town of Boulder Junction - North Creek Loop Trail Project (Fiduciary Account)</u>

Van Grinsven reported that as of the end of December there is total of \$119, 466.77 in the North Creek Loop Bike Trail Project Fund. A check for \$217,299 was issued to the Town of Boulder Junction, which reflects the donations to meet the match requirement of the DNR Knowles-Nelson Grant, and was presented at the Town meeting on December 21, 2022.

<u>Town of Boulder Junction – Playground Project (Fiduciary Account)</u>

Van Grinsven reported that as of the end of December there is total of \$103,991.00 in the Playground Project Fund. The Town will be paying the remainder of their playground equipment bill in February. Van Grinvsen will report to the Town the amount available in the fund at their next meeting on January 24, 2023.
