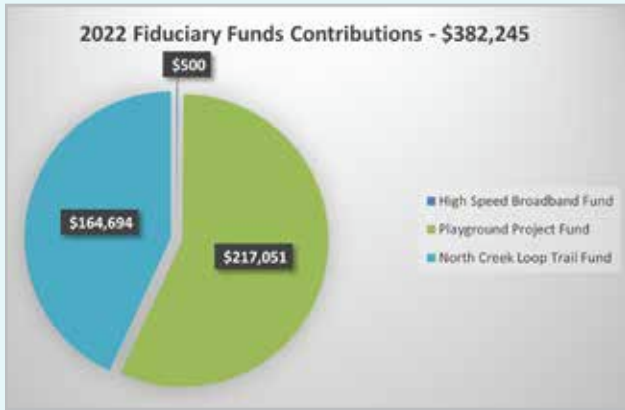

Financials

The Boulder Junction Community Foundation is a 501(c)(3). The Finance Committee and Board of Directors monitor and review the investment management services provided by the Community Foundation of North Central Wisconsin in managing the Boulder Junction Community Foundation Endowment Fund. In 2022, as approved by the Board of Directors, \$170,075 was contributed to the Restricted Endowment Fund, bringing our Fund total at the end of the year to \$698,521.03. Community Enhancement Funds (Arts & Culture Fund, Bike Trail Fund, Broadband Fund, North Creek Loop Trail Fund, and Greatest Needs Fund) as well as the Reserve Fund are managed directly by the Board of Directors and held at Associated Bank in Boulder Junction. At years end, the Reserve fund had a balance of \$23,000. Grants totaling \$354,193.50 were awarded. Our auditors were Peterson Metz, Ltd.
